Applications are invited from superannuated SSE/JE (Works) of Civil Engg. Department of all Zonal Indian Railways on prescribed Proforma for re-engagement in Construction Organization of Northern Railway are invited for re-engagement, on monthly remuneration by reducing pension from his/her last pay drawn (i.e. Basic Pay+ DA) in exigencies of service for a period of at least Six Months or till filling up the vacancies, whichever is earlier. This scheme of re-engagement is valid up to **01.12.2019**.

1. Who are eligible to apply	Retired Railway employee from Civil Engg. Department who have not reached 64 years 6 months of age on the closing date of notification (to ensure at least Six months service is available after re-engagement) for re-engagement purpose will be eligible.						
2. The Monthly remuneration	The monthly remuneration of a retired employee being re-engaged will be determined by reducing pension from his/her last pay drawn (i.e. Basic Pay + DA)						
3. Period of Engagement	The present scheme of re-engagement of retired employee is upto 01.12.2019 unless extended further by Railway Board. All the re-engagement staff will be discharged immediately on joining of selected candidates from RRB's or on completion of 65 years, or, in case of unsatisfactory service, whichever is earlier.						
4. Whom to apply	To the Chief Administrative Officer/Construction, Northern Railway, Kashmere Gate, Delhi latest by (Date 06.07.2018) through registered post only. Name of post applied for should be clearly mentioned on envelope. The administration shall not be responsible for delay of the Dak receipt.						
5. Documents required to be enclosed with the applications	(a) Application in the prescribed Proforma with photo duly self-attested. (b) Self attested photo copy of pension payment order. (c) Self attested photo copy of Service Certificate.						
6. Selection/Suitability	Suitability of the candidates will be adjudged by committee nominated for the purpose. The selected candidates will be required obtain medical fitness from Sr. DMO, required for the posts before re-engagement.
