2.	Name of work : Upgradation of signaling from STD - 1 to STD -IIR 5 Stations (Piparpur, Bishnathganj, Siwaith, Kohndaur, Mauaimma stations) of SLN-PBH-PFM Section & 5 Stations in SLN-FD & ZBD-JNH Section of LKO Division.
3.	Approximate Cost : Rs. 80,78,041/- (Rupees Eighty Lacs Seventy Eight Thousand Forty One Only)
4.	Tender Cost : NIL

10.	Eligibility Criteria : The tenderer(s) shall be eligible only if he / they fulfill eligibility criteria.
10.a	Technical eligibility criteria : 1. Tenderer shall have a valid Electrical Contractor's License issued in the name of the firm by any State Government and shall furnish/attach all the particulars of the Electrical license along with their offer.
10.b	Technical Eligibility Criteria – Similar nature of work : The Tenderer must have successfully completed or substantially completed any one of the following categories of work(s) during last 07 (seven) years, ending last day of month previous to the one in which tender is invited: (i) Three similar works costing not less than the amount equal to 30% of advertised value of the tender, or (ii) Two similar works costing not less than the amount equal to 40% of advertised value of the tender, or (iii) One similar works costing not less than the amount equal to 60% of advertised value of the tender.
10.c	Definition of Similar nature of work : For this tender the following work only will be considered similar work for judging the technical eligibility criteria. Wiring/Rewiring in building with associated electrical works, Or Lighting arrangement in building, circulating area, yard, street etc. with associated electrical works, Or Wiring/rewiring, lighting arrangement in buildings with associated electrical works.
10.d	Financial eligibility criteria : The tenderer must have minimum average annual contractual turnover of V/N or 'V' whichever is less; where V= Advertised value of the tender in crores of Rupees N= Number of years prescribed for completion of work for which bids have been invited. The average annual contractual turnover shall be calculated as an average of "total contractual payments" in the previous three financial years, as per the audited balance sheet. However, in case balance sheet of the previous year is yet to be prepared/audited, the audited balance sheet of the fourth previous year shall be considered for calculating average annual contractual turnover. The tenderers shall submit requisite information as per Annexure-VIIB, along with copies of Audited Balance Sheets duly certified by the Chartered Accountant/Certificate from Chartered Accountant duly supported by Audited Balance Sheet.
