Sr. Divisional Electrical Engineer/General, Hazratganj, DRM office, Lucknow for & on behalf of President of India, invites open Tender through online (e-tendering) for the following work:-

2.	Name of work : Electrical Work in Connection with Capacity Augmentation of Passengers Amenities Including Improvement of Drainage, Water Supply & other Allied Works to Cater Additional rush at Ayodhya Station.
3.	Approximate Cost : Rs. 65,75,583.45/- (Rupees Sixty Five Lacs Seventy Five Thousand Five Hundred Eighty Three and Forty Five Paise Only).
4.	Tender Cost : Nil
5.	Earnest Money : Rs. 1,31,600/- (Rupees One Lac Thirty One Thousand Six Hundred Only).

10.	Eligibility Criteria : The tenderer(s) shall be eligible only if he / they fulfill eligibility criteria.
10. a	Technical eligibility criteria : 1. Tenderer shall have a valid Electrical Contractor's License issued in the name of the firm by any State Government and shall furnish/attach all the particulars of the Electrical license along with their offer.
10. b	Technical Eligibility Criteria – Similar nature of work : The Tenderer must have successfully completed or substantially completed any one of the following categories of work(s) during last 07 (seven) years, ending last day of month previous to the one in which tender is invited: (i) Three similar works costing not less than the amount equal to 30% of advertised value of the tender, or (ii) Two similar works costing not less than the amount equal to 40% of advertised value of the tender, or (iii) One similar work costing not less than the amount equal to 60% of advertised value of the tender.
10. c	Definition of Similar nature of work : For this tender the following work only will be considered similar work for judging the technical eligibility criteria. "Supply, Installation, Testing & Commissioning of Facade Lighting arrangements/Glow sign/Neon Signboards/LED signage & name boards/Fountain lights/Fancy lights/Heritage lights arrangements and associate electrical works."
10. d	Financial eligibility criteria : The tenderer must have minimum average annual contractual turnover of V/N or V whichever is less; where V = Advertised value of the tender in crores of Rupees N = Number of years prescribed for completion of work for which bids have been invited. The average annual contractual turnover shall be calculated as an average of "total contractual payments" in the previous three financial years, as per the audited balance sheet. However, in case balance sheet of the previous year is yet to be prepared/audited, the audited balance sheet of the fourth previous year shall be considered for calculating average annual contractual turnover. The tenderers shall submit requisite information as per Annexure-VIIB, along with copies of Audited Balance Sheets duly certified by the Chartered Accountant/Certificate from Chartered Accountant duly supported by Audited Balance Sheet.
